#### RESEARCH AND DEVELOPMENT

### RULES, REGULATIONS AND CONDITIONS TO BE FULLFILLED BY AFFILIATED COLLEGES FOR RECOGNITION AS RESERCH CENTRES

- 1. The relevant P.G. Course in Engineering/Pharmacy/Management must be in existence for at least last FIVE years and Name of the Branch/Department in which Ph.D. program is to be offered must be declared with specialization.
- The Institute should have minimum UGC 2f reorganization. The Institute should have NAAC Accreditation or UGC Autonomous Status. The Department which seeking Research Centre should have NBA Accreditation.
- 3. Necessary amount per course as prescribed by the University should be invested for procurement of latest journals and books.
- 4. An amount per course prescribed by the University should be invested upgrade the Laboratory facilities for courses.
- 5. At least two eligible faculty members (according to 2018-19 Ph.D. regulations) should be available in the concerned discipline.
- 6. The proposed supervisor should have a Ph.D. degree in the relevant discipline from a reputed University with a minimum of seven years teaching/research experience, out of which the post Ph.D. experience should be two years and having required publications as per 2018-19 Ph.D. regulations. Further, supervisor services should be ratified by the University.
- 7. If the Supervisor retires or leaves the Institution during the period of research, the research student may be transferred to any other eligible guide or to any other research centre recognized by the JNTUA, Ananthapuramu. In any case the student must be paid stifund by the Institution. The decision of the University is final in this regard.
- 8. If the student is willing to get transferred to any other recognized research centre, within JNTUA, then host Institution where the candidate is transferred, as to pay the scholarship for the remaining period.

- 9. The Institute/Organization shall be willing to provide the expenditure for contingencies/conferences/field works/stationary etc.
- 10. The Institute/Organization shall be willing to offer to the scholar a minimum fellowship of the amounts as per AICTE/UGC norms up to the end of 3<sup>rd</sup> year. ie., minimum period of Ph.D. Programme.
- 11. Institute/Organization must provide Networking/Internet facilities/Laboratory/equipment etc., for Research Scholars.
- 12. The Institute/Organization must give assurance regarding availability of allotted Supervisor for the Research programme and Supervisor should be available in the department continuously till the thesis submission of the Student. Otherwise, College has to pay a minimum panel fee of Rs.1,00,000/- (Rupees one lakh).
- 13. Details of stifund and attendance particulars of the full-time scholars are to be submitted by the respective research centres to the University on or before 15<sup>th</sup> July every year.
- 14. The research scholar admitted, should not be given any theory load and may be allowed to take maximum 3 laboratory sessions in his area of research work. He/She should devote full time for carrying out research only.
- 15. The Institute/Organization must give assurance by way of submitting prescribed affidavit.

(Not withstanding anything contained in the above in exceptional cases, the Vice-Chancellor can review and take a decision which is final)

#### ACCOUNTABILITY AND RESPONSIBILITY

- 1. Such recognized Institution shall be accountable to the University in the following manner:
  - 1. Shall submit Report annual reports of the Progress and Research work being done in the Institute.
  - 2. Progress Report of the Research student/Research work being done shall be submitted periodically or as and when called for by the University
  - 3. Number of Research students registered after the grant of Recognition.
  - 4. Keep the University informed about its efforts in seeking Grants/Funding from National and International Agencies based on the Research Status provided by the University.

#### RESEARCH CENTRE GUIDELINES

## (Information to be obtained from the Institutes interested in applying for Recognition as Research Centres)

- 1. Name of the Dept./Branch in which Ph.D. Programme is to be offered.
- 2. No. of Professors with Ph.D. in the Dept./Branch.
- 3. No. of Faculty with Ph.D. in the Dept./ Branch.
- 4. Has the Department been NBA Accredited? If yes, (i) Period of Accreditation (ii) Present Status.
- 5. Whether the Institute is Accredited by NAAC or having UGC autonomous status? If yes, period of Accreditation/Autonomous status and present status.
- 6. Assurance from the Institute/Organization regarding Availability of Allotted Supervisor for the Research Programme Period continuously till the thesis submission
- 7. No. of Journal Publications of the faculty of the Dept./Branch for the last 05 years (Science Citation Index (SCI)/SCI-Expanded or Journals having impact factor given by Thomson Reuters or UGC listed journals shall only be considered).
- 8. Academic/Infrastructural Facilities available at the Inst./Organization. (i) Laboratory/equipment Facilities (ii) Assurance on the Availability of the Research Lab./Equipment to the Scholar as needed (iii) Assured Accommodation for the Scholar within the Dept.
- 9. Networking/Internet Facilities.
- 10. Whether the institute/ Organization is willing to offer to the Scholar a minimum fellowship for minimum period of Ph.D. programme (the amounts are as per AICTE/UGC norms).
- 11. Whether the Institute/Organization is willing to provide the expenditure for Contingencies/Conferences/Field works/Stationery etc.
- 12. Whether the Institute/Organization is willing to share revenue outcomes- if any, and share IPR with JNTUA.
- 13. Number of (i) R & D Projects carried out by the Dept., (ii) Research or any other Gants Sanctioned to the Dept. / Branch.
- 14. Any other information regarding Recognition of the Inst./Org. by any other Universities or Academies or councils or Organizations, or MoU with Industries/R&D Labs.etc.
